DATA PROTECTION NOTICE - PRIVACY POLICY "DOK.FEST MUENCHEN 2021 @HOME"

for the use of audiovisual content of "DOK.fest München 2021 @home"

A. DATA PROTECTION PRINCIPLES

Scope

The following data protection information applies to the visit and use of audiovisual content during the festival "DOK.fest Muenchen 2021 @home" ("Festival" or "Offer") from 05 - 23 May 2021. For the use of other content of the "Internationales Dokumentarfilmfestival München e.V. ", the data protection information on the website at dokfest-muenchen.de applies.

Responsible

The operator named in the imprint is responsible for compliance with data protection.

Data Source

You either actively provide us with your data via an input mask or e-mail or it is collected via our IT systems, cookies or similar technologies.

Purpose of the Survey

You will be informed of the purpose of the data collection in the PRIVACY POLICY at the time of the respective processing.

Legal Basis

Your data is collected either on the basis of consent, for the performance of a contract or on the basis of our legitimate interests.

Your Rights

You have the right to information, correction, restriction of processing or deletion. If the processing is based on consent, you can revoke this at any time for the future; if it is based on a legitimate interest, you can object to this at any time if your interests prevail. You have the right to lodge a complaint with the competent supervisory authority.

B. PRIVACY POLICY

1. Name and Address of the Person Responsible

2. PROVISION OF THE WEBSITE AND CREATION OF LOG FILES (ACCESS DATA)

Each time our website is accessed, our system automatically collects data and information from the computer system of the accessing computer. This includes information about the browser type and version used, the user's operating system, the user's internet service provider, the user's IP address, the date and time of access, websites from which the user's system accesses our website, websites that are accessed by the user's system via our website. This data is stored in the log files of our system. This does not include the user's IP address or other data that enables the data to be assigned to a user. This data is not stored together with other personal data of the user. The legal basis for the temporary storage of the data is Art. 6 para. 1 lit. f DSGVO (GDPR). The temporary storage of the IP address by the system is necessary to enable delivery of the website to the user's computer. For this purpose, the user's IP address must remain stored for the duration of the session. This is also our legitimate interest in data processing according to Art. 6 para. 1 lit. f DSGVO (GDPR).

The data is deleted as soon as it is no longer required to achieve the purpose for which it was collected. In the case of the collection of data for the provision of the website, this is the case when the respective session has ended. The collection of data for the provision of the website and the storage of the data in log files is absolutely necessary for the operation of the website. Consequently, there is no possibility for the user to object.

3. TECHNICALLY NECESSARY COOKIES

Our website uses technically necessary cookies. Cookies are text files that are stored in the internet browser or by the internet browser on the user's computer system. When a user calls up a website, a cookie may be stored on the user's operating system. Cookies contain a characteristic string of

characters that enables the browser to be uniquelyidentified when the website is called up again. Cookies are stored on the user's computer and transmitted to our site by the user.

Some functions of our website require that the calling browser can be identified even after a page change. The user data collected through technically necessary cookies are not used to create user profiles. The legal basis for the processing of personal data using cookies is Art. 6 para. 1 lit. f DSGVO. The purpose of using technically necessary cookies is to simplify the use of websites for users. Some functions of our website cannot be offered without the use of cookies. For these, it is necessary that the browser is recognised even after a page change. This is also our legitimate interest in processing the personal data according to Art. 6 (1) lit. f DSGVO (GDPR). By changing the settings in your internet browser, you can deactivate or restrict the transmission of cookies. Cookies that have already been stored can be deleted at any time. This can also be done automatically. If cookies are deactivated for our website, it may no longer be possible to use all functions of the website to their full extent.

4. ORDER OF A CONTENT

As part of the ordering process, you enter contact and payment data in the input masks provided. This data is used exclusively for processing your order. We only transmit this data to third parties if this is necessary to process the order (payment service provider). The legal basis for data processing is Art. 6 para. 1 lit. b DSGVO (GDPR), which permits the processing of data for the fulfilment of a contract or pre-contractual measures. The collected data will be deleted after the order has been processed and any retention periods have expired. The processing of your order is not possible without the collection of the data.

The country recorded via the IP address is stored and deleted after the expiry of the rental period and any statutory retention periods. The other data is not stored. The collection of this data is necessary to process the contract and to comply with our legal information obligations. The legal basis for this is Art. 6 para. 1 lit b DSGVO (GDPR), as the data is necessary for the processing of the contract.

5. ACCREDITED GUEST

When you register as an Accredited Guest, we collect your first and last name, your e-mail address, the country of your current residence, your professional field and the company of your business. This is done to check and register accreditations for DOK.fest München 2021 @home with regard to the issuing of an accreditation, the provision of audiovisual content and for payment processing. If you do not provide the data, accreditation will not be possible. The data will not be used for purposes other

than accreditation and contract fulfilment. The legal basis for data processing is Art. 6 para. 1 lit. b DSGVO (GDPR).

Furthermore, you can provide us with your address, your biography and your current function. The legal basis for the processing of this data is Art. 6 para. 1 lit. a DSGVO (GDPR).

6. GEOLOCATION

The country from which you are accessing the content is determined on the basis of your IP address recorded when you play the content of our offer. On this basis, it is decided whether the content can be played by you. Your location is not tracked beyond this. The legal basis is Art. 6 para. 1 lit. f DSGVO (GDPR). The determination of your country of residence is necessary because rights of use to content are granted on a limited basis to various territories and the responsible party, as the licensee, is obliged to ensure that the broadcast does not take place in unlicensed territories. This is also our legitimate interest in data processing according to Art. 6 para. 1 lit. f DSGVO (GDPR). The data will not be stored. The determination of your country of residence is mandatory for the use of our offer. Consequently, there is no possibility to object.

7. RETRIEVING A CONTENT

We use an embedded player (integrated player) for our offer to provide the content and to process payments. The provider of this player is PANTAFLIX Technologies GmbH, Neue Schönhauser Straße 16, 10178 Berlin, Germany. When the player is called up, various data (IP address, operating system, browser) are transmitted to the provider in order to ensure optimal use. The data is deleted as soon as it is no longer required for this purpose. The legal basis for the data processing is Art. 6 para. 1 lit. b DSGVO (GDPR), which permits the processing of data for the fulfilment of a contract or pre-contractual measures. In order to use our offer, our cookies must be accepted. The cookies are technically necessary to provide the service. If no consent is given, our offer cannot be used.

8. PAYMENT SERVICE PROVIDER

We have integrated payment services from third-party companies into our offer. If you make a purchase from us, various payment data (e.g. name, payment amount, account data, credit card number) are processed by the payment service provider to process the payment. We integrate the payment service providers into our offers for contract processing (Art. 6 (1) b) DSGVO [GDPR]) and in the interest of a secure, fast and convenient service (Art. 6 (1) f) DSGVO [GDPR]). In the event that

consent is requested, this is based on Art. 6 (1) a) DSGVO, whereby consent can be revoked for the future. We do not store credit card information in connection with the processing of the payment.

For the secure processing of payments initiated by you, the services of the payment service provider Adyen N.V., Simon Carmiggeltstraat 6, 1011DJ Amsterdam, The Netherlands, German branch: Friedrichstraße 63, 10117 Berlin, Germany, are used ("Adyen"). The transfer takes place in accordance with Art. 6 Para. 1 lit. b DSGVO (GDPR), and only insofar as this is necessary for payment processing. Furthermore, we use the services of PayPal for the secure processing of payments. The provider of this payment service is PayPal (Europe) S.à.r.l. et Cie, S.C.A., 22-24 Boulevard Royal, L-2449 Luxembourg ("PayPal"). We pass on your payment data (regularly these are name, address, e-mail address, country of the Paypal account) to Paypal within the framework of payment processing. The transfer takes place in accordance with Art. 6 Para. 1 lit. b DSGVO (GDPR), and only insofar as this is necessary for payment processing. We also use the services of Klarna Bank AB (publ), Sveavägen 46, 1134 Stockholm, Sweden, ("Klarna"), a Swedish company with a German branch: Klarna bank AB, German Branch, Chausseestr. 117, 10115 Berlin, for the secure processing of payments. We pass on your payment data (regularly this includes name, address, e-mail address) to Klarna in the context of payment processing. The transfer takes place in accordance with Art. 6 Para. 1 lit. b DSGVO (GDPR), and only insofar as this is necessary for the payment processing. 9. INVOICING

If you wish, you can request an invoice by clicking on it. For this purpose, you may have to enter further data. We use this data exclusively for the creation of an invoice. The legal basis for data processing is Art. 6 para. 1 lit. b and lit. a. DSGVO (GDPR).

10. CALL DATA

When you access and play content, we process the access data for the content. We record which content you have used in order to enable further functions, such as the continuation of the playback

of the content at a later time. This access data is used to fulfil the contract; the legal basis for data processing is Art. 6 para. 1 lit. b DSGVO (GDPR).

11. DISCLOSURE OF PERSONAL DATA

We will not disclose or otherwise distribute your personal data to third parties unless this is necessary for the performance of our services (legal basis for data processing: Art. 6 para. 1 lit. b) DSGVO [GDPR]), you have consented to the disclosure (legal basis for data processing: Art. 6 para. 1 lit. a) DSGVO [GDPR]) or the disclosure of data is permitted by law.

Within the framework of the data protection requirements for the processing of your personal data, we are entitled to commission external service providers, who act for us as processors in accordance with Art. 4 No. 8 DSGVO (GDPR), with data processing. External service providers support us in the technical operation and support of the offer and payment processing. The external service providers commissioned by us process your data in accordance with our instructions.

Our external service providers process your personal data within the European Union (EU) or the contracting states of the Agreement on the European Economic Area (EEA). However, in the event that your personal data is transferred to a service provider located in a third country and processed there, the protection of your personal data is ensured by means of appropriate guarantees, such as the conclusion of standard data protection clauses.

12. NEWSLETTER

You are given the opportunity to subscribe to our enterprise's newsletter on DOK.fest München 2021. The personal data transmitted to the controller when you subscribe to the newsletter is specified in the input mask used for this purpose. In principle, you can only receive the newsletter if (1) you have a valid e-mail address and (2) you have registered to receive the newsletter. For legal reasons, a confirmation e-mail will be sent to the e-mail address you entered for the first time for the newsletter dispatch using the double opt-in procedure. This confirmation email is used to check whether the owner of the email address as the data subject has authorised receipt of the newsletter.

When you register for the newsletter, we also store the IP address of the computer system used by you at the time of registration, as well as the date and time of registration, as assigned by your internet service provider (ISP). The collection of this data is necessary in order to be able to trace the (possible) misuse of your e-mail address at a later date and therefore serves our legal protection.

The personal data collected in the context of a registration for the newsletter is used exclusively for

sending our newsletter. Furthermore, subscribers to the newsletter could be informed by e-mail if this

is necessary for the operation of the newsletter service or a related registration, as could be the case

in the event of changes to the newsletter offer or changes in the technical circumstances. No personal

data collected as part of the newsletter service will be passed on to third parties. You can cancel your

subscription to our newsletter at any time. The consent to the storage of personal data that you have

given us for the newsletter dispatch can be revoked at any time. For the purpose of revoking consent,

you will find a corresponding link in each newsletter. Furthermore, it is also possible to unsubscribe

from the newsletter at any time directly on the website of the controller or to inform the controller of

this in another way.

13. E-MAIL

Our website contains an e-mail address that you can use to contact us. If you send us an e-mail, the

data transmitted to us with the e-mail will be stored. The data will not be passed on to third parties.

The legal basis for the processing is according to Art. 6 (1) lit. f DSGVO (GDPR). The personal data is

processed solely for the purpose of dealing with your request. This is also our legitimate interest. The

data will be deleted as soon as your request has been conclusively clarified. You can object to the

processing of your data at any time by sending an e-mail to the person responsible. In such a case, the

conversation cannot be continued. All personal data stored in the course of contacting you will be

deleted in this case.

14. DATA SUBJECT RIGHTS/RIGHT TO COMPLAIN

You have the right of access to the personal data concerning you as the right to rectification or erasure

or to restriction of processing or the right to object to processing and the right to data portability.

15. RIGHT OF APPEAL
